- 4.) Price:** The Sale price is to be determined by the Consignor. - 5.) Amount(s) of payments to consignor:** Consignor and Consignee agree that an amount of \$100.00 sell fee is due to Waukegan Auto Auction if the property sells. If the vehicle is presented at Auction and Waukegan Auto Auction is unable to sell said property, a run fee of \$25.00 per each time the property is offered for sale is due to the Waukegan Auto Auction.
- 6.) Liability for Damage, Loss, Theft, Etc.:** In the event that the consigned property is lost, stolen, damaged, destroyed for due to any cause, known or unknown, while consigned to the Waukegan Auto Auction, the Consignor shall hold Waukegan Auto Auction non liable and harmless.
- 7.) Title:** The title to the property being consigned shall remain the possession of Waukegan Auto Auction until the property described is sold or the Consignor pays the fees for "No Sale" to Waukegan Auto Auction.
- 8.) Insurance:** The Consignor warrants that the vehicle being consigned is showing the said vehicle. The Consignor hereby agrees to waive subrogation rights of his or hers insurance carrier.
- 9.) Miscellaneous:** This agreement shall be construed in accordance with the laws of the State of Illinois. If the vehicle is inoperable at the time of sale Waukegan Auto Auction reserves the right to sell this as a "Non Runner." Vehicles may not be removed on the day of auction until after the sale is complete.
- 10.) Storage:** Cars left on Waukegan Auto Auction lot are subject to a \$25.00 per day fee after the second unsuccessful run at the auction. This is in addition to the \$25.00 per run fee.
